

LANDLORD REQUEST FOR RENT INCREASE

Owners may not raise the rent prior to the first anniversary date. Voucher program participants must be allowed to review the proposed increase and sign this form to advise LSHA they wish to accept or reject the increase. If the dwelling unit meets HQS and the owner otherwise is in compliance with the terms of the lease and the owner has requested an adjustment to an amount equal to the lessor of (a) the rent reasonable rent or (b) the amount requested by the owner. The contract rent may be adjusted upward or downward. If the reasonable rent is less than the current rent, the contract rent will be lowered. All increases become effective on the first day of the month and are not prorated or retroactive. This completed form MUST be received by the Lee's Summit Housing Authority sixty (60) days prior to the proposed effective date of the rent increase, which is at the voucher holder's Annual Effective Date / Lease Date. It is the owner's responsibility to return the signed form to the Lee's Summit Housing Authority in a timely fashion.
